

2006 Cuyahoga County Residential Property Tax Rates

Multiply the market value of the home by the percentage listed below to determine the approximate Real Property Taxes in each community. This figure does not include any Special Assessment charges or delinquent taxes due. The tax year 2006 is payable in year 2007.

Example: Annual Taxes on a home in: Fairview Park \$100,000 x 2.50% = \$2,500.00
